1. Opening

Prof. Torlegard welcomed the Council to the Zurich Council Meeting for 1988-1992.

2. Review of the Minutes of the Council Meeting in Kyoto
The minutes were approved.

3. Review of the previous meeting with the Technical Commission Presidents and Council

It was decided that the Minutes of Meeting of Council and Commission Presidents as well as Council Meeting should be mailed to all members.

Prof. Murai will summarize the Action List for Council Members.

4. Ratification of WG's proposed by Technical Commission Presidents

WG's and IC WG's were ratified by Council. Prof. Murai will summarize all details of WG's and IC WG's and mail to members in Jan. 1989.

5. Establishment of further WG's and review of Kyoto Resolutions

See items 6 and 7, the Minutes of Meeting of Council and Commission Presidents.

6. Ratification of dates, places and topics of Symposia, tutorials and other ISPRS meetings

The dates and places of Symposia were ratified. Prof. Murai will request Comm. Presidents to mail the topics of Symposia and terms of reference to General Secretary by Christmas this year.

7. Reports by members of Council

President's Report

Prof. Torlegard submited President's Report.

1st Vice President's Report

Prof. Konecny reported his activities related to international approaches.

2nd Vice President's Report

Dr. Katzarsky explanined his activities with reference to his report which was mailed before the meeting. Dr.Kartzarsky reported FIG's negative attitude to ratification of Statutes of IUSM. Fred Doyle should be invited to Budapest Council Meeting to report the status of FIG and ICA with respect to ratification of IUSM.

Secretary General's Report

Prof.Murai reported the plan of publication of Part A, Archives of Kyoto Congress as well as the new jobs as Secretary General.

Prof.Murai also reported international activities including IAF Congress and Asian Conference on Remote Sensing.

Treasurer's Report

Mr.Atkinson reported the hand-over of tasks from Giovanna Togliatti as well as from Don Proctor.

Mr.Atkinson suggested to open individual accounts of Togliatti, Torlgard, Konecny, Lindig, Trinder and Murai.

Mr.Atkinson requested Council Members to provide him with estimates of expenditure in 1989FY.

Mr.Atkinson anticipated increase of income to Sw.fr.44,784 per annum due to the increase of national member subscriptions.

Regional member subscription for 5 regional members; AARS, EARSeL, OACT, OEEPE and SELPER was decided 72 Sw.fr. as same as for Category 1 of ordinary member.

8. Plans for the Next Congress

Mr. Fritz reported that ASPRS wishes to obtain for Archives of 1992 ISPRS Congress. Council agreed that Mr.Fritz should inform ASPRS that copyright is inappropriate for ISPRS Archives.

13. Inter Society relations

Prof.Konecny reviewed Fred Doyle's letter of August 4, 1988 with respect to ratification of IUSM by ISPRS, FIG and ICA.

Council discussed the approach to ICSU membership which will be clarified at UN New York Meeting on Jan.26-27,1989 and at IUSM General Assembly, Budapest, Aug. 17,1989.

The next JOBRESA Meeting will be held during Vancouver IGARSS-Congress, July 10-14,1989, which Prof. Konecny, Mr. Fritz and maybe Prof. Murai will attend.

Prof.Konecny, Prof.Togliatti and Mr.Hegyi will attend Venice IUFRO Congress, Sept.24-30,1989.

Prof.Murai will attend Beijing IAF Congress, Oct.7-13,1989.

Council decided to leave Prof.Murai to determine the price of Member List(blue book), which will updated annually by Prof.Murai.

14. Matter related to Technical Commissions Council decided to be helpful to support the activities of Com.VI which was reformed drastically.
