K. Torlegard stressed the main topics for discussion including the proposal of amendment of Statutes by France, ISPRS official Journal, multiple membership, Awards, support to developing countries etc.

d. General Secretary's Report

S. Murai reported on his international activities, member status, applications of Council, Technical Commissions and Awards, guidelines for working groups and others.

e. Treasurer's Report

K. Atkinson reported that there are members who have not paid their subscription for many years. 9 members are very seriously in arrears. Bolivia, Burkina Faso, Congo, Libya, Mexico, Nigeria, Sudan, Surinam and Zaire.

The Council will ensure the financial support for David Tait to attend the Council Meetings in future.

The subscription rate for 1992-1996 was proposed by the Treasurer to consider an increase in the unit contribution. The Swiss inflation is approximately 20 % over 4 years.

The proposal of 25 % increase was suggested but will be discussed finally at Glasgow Meeting.

The proposal would be decided on at the General Assembly.

5. Financial Commission's Report

- J. Trinder reported that
- 1) the document of income and expenditure for 1990 was approved
- 2) the expenditure was Swf 12,929.20 in excess of budget
- 3) the total shortfall in ISPRS funds during the fiscal year 1990 was Swf 12,026.45.
- 4) Income was Swf 9,346.33 less than budget due to non payment by members. Council should consider procedures to recoop the unpaid dues.

6. Member Status

The Council discussed how to support developing countries in arrears. Then the Council suggested that some companies such as Carl Zeiss, Matra, Intergraph etc. should be asked to pay for the unpaid amount.

Because of the failure in communication with OACT, Gottfried Konecny will try to contact the representative of OACT. Action 5-102-G0T

Gabbys Sustaining Membership will be cancelled. Aerofoto Cruzeiro, Precision Photolabs, Kucera and Aerodata-Aerofotogrametria should be traced through the personal contact of L. Fritz and P.Fagundes. Action 5-103-LRY/KTH

L. Fritz reported that he has received a letter concerning new membership from Michel Maas, Luxembourg. S. Murai should mail an application form to Luxembourg. Same to Oman. Action 5-104-SHN

7. Preparation for Washington Congress

L. Fritz explained the program of Washington Congress. He presented a proposed draft of the Opening Ceremony, Archives, presentation of Awards, Best Poster Awards, abstracts, developing country assistance, WG Chair VI/6 appointment, Council Member office etc.

David Tait will survey the activity of J. Hothmer concerning WG VI/6 and try to find an appropriate person who can take the chair.

L. Fritz asked the Council to advise on the priorities of participants who will be sponsored by USA. The Council suggested several persons to be provided with the financial support.

- D. Tait explained the ISPRS official Journal affairs including the agreement of Chief Editor, the negotiation with Elsevier, transfer of the files of J. Hothmer, review process, submission of papers, News Editor, etc.
